**LICENSING INFORMATION:** In Illinois, the **Department of Children and Family Services (DCFS)** is responsible for setting standards and licensing child care centers, family child care, homes, group homes and day care agencies in the State of Illinois. According to the DCFS regulations, early childhood teachers must be at least 19 years old, have completed two years of college, or must have equivalent experience and credentials. The director, teachers, and all child care staff must have 15 hours of in-service training annually. All child care center staff are subject to background checks for any record of criminal conviction or child abuse and neglect.
